We accomplish this with an education process that uses the following resources: the Nelson Scenic Loop, Spruce Creek Park, the Natural History Center, six miles in the Rockfish Valley Trail System, and lands associated with them. The mission further supports conservation, recreation, preservation, agricultural and environmental education and promotes a rural tourism experience in the Rockfish Valley of Nelson County, Virginia. We aim to inspire a healthy lifestyle by offering hiking trails, a public park, programs & events. We support all students whether in Nelson public schools, home schools or private schools. The lands serve as our outdoor laboratory for students, the community and visitors alike. Our vision is to enhance environmental literacy & create better stewards. Our tag lines are "we are the nature guys" and Nature is our game.

distancing were required outdoors and indoor areas were closed. Visitation estimated for river trail increased from 10,000 to 15,000 and more than doubled at Spruce Creek Park from 4000 to over 8000 visitors. Families and children especially took advantage of our access to outdoor play and learning. To handle the increased grounds maintenance, the Volunteer Committee recruited trail monitors and increased maintenance, such as more frequent removal of trash. Significant improvements were made to the Reid's Creek Bridge and structures. A grant with VA Department of Forestry, Chesapeake Bay Fdn and the James River Assoc for Rockfish stream buffer planting saw 570 trees and shrubs installed; and Still House Branch was cleaned. An ash tree borer grant was implemented and an oversize tree at Glenthorne Loop and Route 151 was removed with extension equipment and a road closure. The Geology Committee accomplished a great deal including new maps under the direction of Dr Chuck Bailey, Wm & Mary University. A public lecture on Nelson County's unique geology was prepared by him and he also lectured via Zoom to a wide audience with on Nelson County geology. Additionally, another lecturer was Dr Callen Bentley from James Madison University. These lectures are available via YouTube. While Spruce Creek Park visitation more than doubled, gathering together was restricted including the vary popular Mud Kitchen. In 2020, park maintenance work included repairing wood constructions, sanding and staining with wood preservatives. The Gazebo was repaired, re-screened and provided with lights.

installation of new exhibits were undertaken for its reopening in 2021. During 2020 several events were planned and subsequently cancelled or held online due to Covid 19 mandates. Events included the Celebration of the 15 Years since the Foundation's founding. Video productions and on-line presentations made this a success, nonetheless. Old Wintergreen Day and Earth Day were also prepared for but cancelled as well. A Native Plant Walk was designed but later cancelled. One grant provider postponed its funding of support in order to focus on Covid 19 related projects. The same was true by local community foundations. The Foundation did receive an SBA Paycheck Protection Loan to assist with payroll costs required for these programs, therefore, the loan was forgiven in 2021 and recognized as a grant in 2020. Chesapeake Bay Restoration Fund also delayed the payout of grants, but RVF has been assured that \$8000 will be allocated to Spruce Creek Park program development. The education committee hired a grant funded professional educator who was employed six months, in which time progress was made building an education program with the public and private schools, plus the homeschool community. The educator also developed a 50th Anniversary Earth Day event and better defined the Foundation's future school programs. All were cancelled due to Covid. Additionally a consultant was hired to review our educational outreach programming and was advised to hold off and set aside.

community foundations: BAMA Works and Charlottesville Area Community Foundation. The NEPA government environmental review was completed in mid year in 2020 and search began for a ENLIT project manager with a positive result in 2021. The project develops environmental content to be displayed thru NFC tags and other connectivity on the trails and within the park. A content provider will provide a program or educational trail walk video experience. These content creators will be drawn from the staff of state agencies, the area schools, nonprofits, and, in particular, those associated with the Virginia Conservation Network. This will be a unique outdoor education program in Virginia. ENLIT is a transformational and multi year project, and with it comes the necessity to refresh administration practices and capacity. Most task have been performed by the founders and transition is underway. The Foundation will seek to build work toolboxes and task templates. RVF was awarded a grant in August to use Catchafire services, and began projects that support the transition work, trustee recruitment, and governance refresh for the benefit of the community continuity.
