The volunteers created Camp Rockfish for young children and built on the concept of Rockfish Rangers crated under our intern Evan Spears the previous year. the committee realized the need to create materials that linked the center with the outdoors of Spruce Creek Park. A volunteer created a massive display of pressed leaves with info on trees. Others set out the Smokey the Bear poster unit. a family gets a free poster but must make a donation to get a second one. at the same time printed materials were enhanced to support various areas of education.
